#### **ABOUT US**



In 2012 founders Alice Glenn and Elizabeth Barnett noticed a dearth of welcoming, inclusive and diverse arts spaces in the community. The hallowed site was St. Joseph's Technical College in Abbotsford, which was converted into an impressive arts hub boasting studios, a gallery, an events space, a backyard orchard and even a basketball court. Schoolhouse Studios came to life.

Fast forward to 2015, Rupert St, Collingwood and Cross St, Brunswick East, two retrofitted warehouse studios were born with artists, NGO's and creative businesses across both sites. Our model during this time grew to incorporate private and shared studio spaces, a cafe, gallery, bar and event space with a full calendar of gigs, performances, exhibitions, professional development workshops and artistic residencies with grants.

In 2021, Schoolhouse Studios signed a lease agreement with Coles and Merri-bek City Council for the former supermarket building in Coburg, next to Coburg Station. This is now our current home. We house a gallery, and event spaces including an outdoor courtyard and loading dock.

Today, we are an ACNC registered not-for-profit cultural organisation with DGR status.

2023 has seen many exciting changes and evolutions within the Schoolhouse org. One of the biggest developments was the change in Directors with Holly Fifer stepping down after a 3yr successful tenure in the role.

After a considered recruitment process we were very lucky to have Bron Belcher accept the role as Director for SHS in February 2023. Bron's approach to the space has seen so many positive internal updates to process and structure.

One major key event for 2023 was our annual planning day with Bron & targeted on our yearly strategy with some core focuses being long term plans for the building, tenancy retention, council advocacy and ongoing budget and fundraising planning.

Another core outcome of this strategy session was the creation of the board 3 sub-committees: Governance & Finance, Fundraising and Events and Communications. The intention was to create more focussed sub groups to allow for improvements and actions in the areas that we highlighted as priorities for the yearly plan.

In March of 2023 we welcomed Lore Awaad as our new Operations Manager working very closely with Bron across the day to day running and administrative needs within the space.

2023 also saw the board welcome Deanna Smart as Treasurer. Deanna brings to the organisation a wealth of knowledge and background in the arts and has previously worked as Co-CEO of Dancenorth and is currently Head of Creative Program at RISING Festival.

Chair's Report We would like to extend our sincere thanks to Merri-bek Council, The Mayor Angelica Panopoulos, our management team and of course our incredible community of artists and residents within the space. The investment in community connection within Coburg and the surrounding organisations is integral to the ongoing success of Schoolhouse Studios so we are very grateful for the ongoing support from our stakeholders and friends and family of the space.

2023 has been an era for growth at Schoolhouse Studios. We started the year with all new staff and a doubling of our available studios, and it's been non-stop since.

I have learned a lot about who we are inside and out; mostly by listening hard and being present. My key takeaways are that we are deeply impacted by what the lights decide to do on any given day, and that temperature control in our beloved old Coles building is integral for good work to happen. I also learned that we all appreciate it when there is a lot happening, when there are plenty of things to bring us out of our studios and get us working together.

I saw this in action with *Warm Welcome*, our first resident's exhibition in June. An experiment that paid off; the exhibition was a perfect coming together for our residents and a great way to get acquainted with each other's work. Whether it was helping curate, performing at the opening, or exhibiting work, residents contributed wholly and our community came to support, so much so we had to extend the exhibition an extra week. We are committed to making an exhibition like this a seasonal fixture and are already planning Summer 2024.

Another event building momentum is our market. Each one has had a different character, shaped by who gets involved. I love seeing the building full of dogs, families, art, music, snacks. Our Kid's Market introduced us to the next generation of budding creative entrepreneurs and we spread into new areas of our building to accommodate, with bands and sausage sizzles in the courtyard and mask-making workshops and portraits in the gallery.

# gallery. A collaboration with Merri-bek City Council brought the work of our residents out into Coburg along Louisa Street. Working with Abbey Rich to design and deliver, ten residents painted planters that have made Louisa St a little brighter and hopefully slightly

safer (for anyone who is familiar with chaos of cars and pedestrians that can take place out there!). This is the first phase of three and we look forward to continuing work with Council to platform the work of our creatives locally.

Our resident community doubled, there was an uptick in exhibition openings and events, and we finally cleaned our front windows. It's been great.

I want to thank our Chair and Board Members for their ongoing support. I am so proud and privileged to spend my days as part of the Schoolhouse Studios community, and we are looking forward to what 2024 has in store.

# Director's

### Report

#### **Bron Belcher**



Being a resident at SHS has given me the confidence and resources to run my first solo exhibition. Equitable access to the gallery space has been invaluable for me as an emerging artist.

I've been in many studios over the past 10 years and I think SHS is my favourite. People in studios often talk about community without any support or sense of community but at SHS it seems genuine and that means a lot as a sometimes sole trader who works alone. The temperature control was amazing in winter, great to not have to wear 8 layers of clothes.

#### From Our Residents

Schoolhouse is a fantastic space to share with like-minded creatives. I always feel supported by the community and feel welcome to bring my ideas and thoughts to the space.

I am very grateful to have space at SHS, it has allowed me to continue my art practice at weird hours while I juggle children and teaching life. My hope to to use it more and more in the future and be a bigger part of the community.

SHS has helped me establish a home for my practise where I feel safe and secured. I feel supported and part of something bigger than myself.

I love my studio and the amazing girls Bron and Loor.

#### **RESIDENTS STATISTICS**



Schoolhouse Studios is currently home to 87 artists and creatives, encompassing a broad range of practices and uses for our building. We have 64 different studio spaces, and we added Studio 25 to our shared spaces available to anyone by the hour. The resident community requires different things from our space and we are glad to have accommodated so many distinct groups and variety.

We hosted over 300+ events; exhibitions, classes, gigs, film screenings, workshops, festivals and markets and raised \$395,000 revenue this financial year.

The annual Tenant Survey helped us better understand who we are.

70% women
55% LGBTQIA
22% with a disability
33% CALD
63% living in Merri-bek

It also provided invaluable insights for enhancing Schoolhouse's services. Key findings underlined a desire for more professional development and grant writing workshops, and a high level of collaboration across the space. 95% of tenants have met more than one new person, and 32% have undertaken one or more paid projects borne from those new connections. The main concerns cited were general maintenance and lighting (42%) and a few wished we did a little more weeding (11%).

63% were satisfied with their experience at Schoolhouse, and the remaining 37% were very satisfied. 100% of residents surveyed said they felt Schoolhouse staff were supportive and approachable.

#### **SHS Markets**

We ran four bi-monthly markets, partnering with Merri-bek City Council to feature live music and food trucks for our markets in October. We have an average of 40 local stallholders and a Trans N Treasure.

#### **Joke Club**

A flagship school holiday program, we received a grant from Inner North Foundation to run comedy workshops for children ages 8 - 12. We met 13 budding comedians over the two-day workshop.

# **Residents Exhibition**

Warm Welcome was our inaugural Residents Exhibition, featuring works from 26 residents, and opening night performances. The exhibition was extended a week due to popularity.
